If the account number is not visible on a financial account statement, you must label the statement with the last 4 digits of the account number.

You may have to attend another meeting of creditors if you fail to give the Trustee the Questionnaire and the requested documents before the meeting. Unless your attorney is going to provide these to the Trustee, mail or email this Questionnaire and the documents to the mail or email address above.
